

Consumer Price Index (Dec 2012 = 100) – December 2018

The year on year inflation rate (*annual percentage change*) for the month of December 2018 as measured by the all items Consumer Price Index (CPI) stood at 42.09 percent, gaining 11.08 percentage points on the November 2018 rate of 31.01 percent. **(see note on period of data collection on the next page).**

This means that prices as measured by the all items CPI increased by an average of 42.09 percent between December 2017 and December 2018.

- *The year-on-year inflation rate is given by the percentage change in the index of the relevant month of the current year compared with the index of the same month in the previous year.*

The year on year Food and Non Alcoholic beverages inflation prone to transitory shocks stood at 53.68 percent whilst the Non-food inflation rate was 36.48 percent.

The month on month inflation rate in December 2018 was 9.03 percent shedding 0.17 percentage points on the November 2018 rate of 9.20 percent.

This means that prices as measured by the all items CPI increased by an average rate of 9.03 percent from November 2018 to December 2018.

- *The month-on-month inflation rate is given by the percentage change in the index of the relevant month of the current year compared with the index of the previous month in the current year.*

The month on month Food and Non Alcoholic Beverages inflation rate stood at 9.07 percent in December 2018, shedding 5.46 percentage points on the November 2018 rate of 14.53 percent. The month on month non-food inflation rate stood at 9.01 percent, gaining 2.51 percentage points on the November 2018 rate of 6.50 percent.

The CPI for the month ending December 2018 stood at 141.36 compared to 129.65 in November 2018 and 99.49 in December 2017.

Period of Data Collection

It is important to note that data on prices was collected during the period covering five days around 15 December 2018. The changes in prices in this report refer to that period.

THE NEW CONSUMER PRICE INDEX

With effect from January 2013 ZIMSTAT is publishing the new Consumer Price Index (CPI) with new weights and a new classification in accordance with international guidelines. The use of a new Classification of Individual Consumption by Purpose (COICOP) resulted in the creation of a new classification which resulted in coming up with 83 classes, 41 groups and 12 divisions while in the old classification there were 68 subgroups and 12 major groups. The number of items in the CPI basket has also been increased from 428 to 495.

Due to the reclassification that has been done, the sub-groups and major groups have been substituted by classes, groups and divisions.

The implementation of the COICOP classification is also part of the harmonisation project of Consumer Price Indices in different regions like the SADC region. All member states are supposed to adopt the new procedure to enable inter country comparisons of the CPI and the rate of inflation. The indices prior to January 2013 were re-referenced to December 2012=100. The rates of inflation remain the same under different weight regimes as the relative magnitude of indices is main-

tained. The new weights are therefore applicable from January 2013 onwards.

LINKING THE 2008=100 WITH THE 2012=100 BASE AT ALL ITEMS LEVEL

Users who wish to continue using the old series (the Dec 2008=100 base) are advised to multiply the current all items index with a new base of (Dec 2012=100) by a conversion factor of 1.0290211. For instance if ZIMSTAT had continued with the old base (2008=100), the December 2018 all items CPI was going to be 145.467.
